## 3. SECURITY BOND FEE

This is a compulsory refundable security deposit for all dead ship movement into, out and within the harbours of a declared port held to meet unexpected damage costs arising out of the dead ship movement. The fee is refunded at the end of the operation less damages costs, outstanding fees, costs and charges.

## 5. SHIP TO SHIP TRANSFER FEES
