



2025 ESSENTIAL PORT SERVICES TARIFF SCHEDULE

PNG Ports Corporation Limited (PNG Ports) informs all its valued clients and industry stakeholders that the Independent Consumer and Competition Commission (ICCC) has assessed and approved the PNG Ports 2025 Essential Port Services (EPS) Tariffs to be applied in accordance with Clause 3.1(d) of the PNG Ports Regulatory Contract (2020 – 2024).

Accordingly, PNG Ports advises that these adjustments to the rates will take effect on the **1st April 2025**. The EPS tariffs to be applied are detailed below.

A. MAXIMUM TARIFFS FOR WHARFAGE SERVICES

The maximum amount that PNG Ports will charge for the supply of a Wharfage Service as of 1st April 2025 is outlined in the following two tables, representing two groups of Declared Ports; Tier 1 & Tier 2

Where:

Tonne means one cubic metre.

Weight means 1,000 kilograms or, in the case of bulk oil, oils or petroleum, 1,000 litres.

If the Unit is specified to be "Tonne/Weight", the applicable tariff is the greater of the tariff calculated on the basis of the number of Tonnes of the cargo loaded or unloaded (as the case may be) and the Weight of the cargo loaded or unloaded (as the case may be).

"Overseas Cargo - Inward" means cargo to be unloaded from a vessel in PNG, which cargo was loaded onto the vessel at any place outside of PNG.

"Overseas Cargo – Outward" means cargo loaded onto a vessel in PNG, which cargo is intended at the time of loading to be unloaded at any place outside of PNG.

"Coastal Cargo – Inward" means cargo to be unloaded from a vessel in PNG, which cargo was loaded onto the vessel at any place within PNG.

"Coastal Cargo – Outward" means cargo loaded from a vessel in PNG, which cargo is intended at the time of loading to be unloaded at any place within PNG.

B. TRANSHIPMENTS

The tariffs for transshipments (inward and outward charged separately) will be charged at, for Overseas – 50%, and for Coastal – 100%, of the wharfage tariffs above.

C. MAXIMUM TARIFFS FOR BERTH RESERVATION SERVICES

The maximum amount that PNG Ports will charge for the supply of a Berth Reservation Service as of 1st April 2025 in respect of a particular vessel is the tariff set out in the following two tables.

PNG Ports wharf means a wharf in a Declared Port owned, operated or controlled by PNG Ports. A coastal vessel carrying cargo loaded at any place outside of PNG will be charged for Berthing Services at the rate applicable for overseas vessels until such overseas cargo is completely unloaded at which time it will revert to being a coastal vessel.

The maximum amount that will be charged as a Passenger Fee as of 1st April 2025 is the tariff set out in the following two table (Child < age 13, Adult > age 13)
